Contribution information: Proceeds will benefit the New Jersey Republican State Committee. Contributions of up to \$10,000 from individuals will be deposited in the federal account for use in federal elections, unless specifically requested otherwise. Contributions exceeding federal limits will be deposited into the state account and are subject to the limits of the state election law. New Jersey Republican State Committee Federal Account: Individuals, and non-multicandidate federal PACs may contribute up to \$10,000 per contributor per calendar year (spouses are considered separate contributors); federal multi-candidate PACs may contribute up to \$5,000 per calendar year. Contributions from incorporated entities are prohibited to the federal account. New Jersey Republican State Committee State Account: New Jersey law prohibits entities operating in certain regulated industries (casinos, financial institutions, insurance companies, utilities) from contributing. Business entities doing or seeking to do business with the State of New Jersey and certain individuals associated with those vendors may also be prohibited from contributing in excess of \$300 per calendar year per political party. NJ Election Law allows contributions with a limit of \$25,000 annually from individuals, PACs and corporations.

A partnership or limited liability company may not contribute as an entity. However, a check from a partnership or limited liability company may be accepted so long as it is accompanied by a letter allocating the contribution to the individual partner(s) or member(s) and is signed by each contributing partner or member. The letter must include each contributing partner's or member's home address. A partner's or member's total contribution, through the partnership or limited liability company and personally, cannot exceed the \$25,000 annual limit.

I hereby certify that:

- The funds being contributed are my own and were not provided to me by another person or entity for the purpose of making this contribution.
- I am not a "business entity" nor am I the spouse or child of an individual meeting the definition of a "business entity" as defined by N.J.S.A. 19:44A-20.3 et seq. and by Executive Order 117, that holds or is seeking a contract with the State of New Jersey in an amount of \$17,500 or I am contributing an amount less than \$300.

Contributions to either the Federal or State account are not deductible for income tax purposes.
